COURSE DESCRIPTION

Traces historical foundations of sport and recreation in America.

Through the utilization of scholarly interpretations, students examine a variety of topics, including the role of sport in ancient Greek culture, nature of sport in Renaissance society, the interrelationship between exercise and health in nineteenth century America, and the rising interest in physical culture in contemporary society. Particular attention is devoted to the role of various ethnic and racial groups in American sport and the development of the sport and recreation professions.

COURSE OBJECTIVES

At the completion of this course students should be able to:

- 1. Describe how recreation and sport developed as they moved from a preindustrial to a postindustrial culture.
- 2. Demonstrate the interrelationship between sport and the health and recreation professions in contemporary American society.
- 3. Identify the major trends in society and how they influenced the recreation and sport professions.
- 4. Describe the role played by various ethnic and racial groups in sport and recreation.

- *Presentation:* Students are divided into groups and asked to make a presentation on an important individual from the world of recreation or sport. They will be evaluated on content, historical accuracy, and the ability to create dialogue and discussion among the rest of the students in the class.
