## **University Catalog Course Description**

### **Course Overview**

Immerses students in Jamaican culture and a first-hand understanding of the effects of globalization on the Jamaican peoples by experiencing the reciprocal impacts between tourism and culture. Examines these issues through an exploration of specific local practices by participating in and observing tourism-related leisure. Emphases how the tourism industry impacts cultural practices, people, international relations and economy of Jamaica, as well as how tourism and culture reflect Jamaica's history, race relations, economy, local and global marketing priorities, and the role of western global dominance.

## **Course Delivery Method**

Lecture and seminar. On-site (off-campus) instruction.

# **Learner Outcomes or Objectives**

This course is designed to enable students to do the following:

• Explain the reciprocal impacts of tourism and culture;

- Identify marketable heritage and cultural resources, including art, dance, music, food and sport, and their relative contributions to the tourism experience;
- Understanding the principles and practices of stewardship and use of natural and cultural resources and the ability to interpret them to the general public, particularly as related to the public's role in stewardship.
- Assess the tourism potential of cultural assets and evaluate cultural, heritage, and sport tourism programs and/or products;
- Articulate the concept of sustainable management for cultural tourism;
- Develop tools to mitigate negative impacts of tourism on social structures.
